SUPERINTENDENT'S REPORT

The Open House at Delta Charter School was inspiring, as was the Schools Plus event where teachers who received grants last year reviewed their projects. 8.3.3. Staff Report: CTEIG Grant

Mr. Wells introduced Secondary Curriculum Director Mekis to report to the Trustees. Ms. Mekis reported that the Career Technical Education Incentive Grant (CTEIG) provides funding to support existing career education pathways and to create new pathways. All CTEIG funds must be matched by district funds. Some of the current grant resources are dedicated to offset the current Memorandum of Understanding (MOU) with the County Office of Education regarding Regional Occupational Programs (ROP); others support a new Computer Science pathway for students. The Computer Science Pathways will implement two new coursres -- "Intro to Computer Science" and "Advanced Placement Computer Science" at all three comprehensive high schools. Teachers will receive training and infrastructure will be prepared for the new pathway implementation. Following discussion, comments and questions among Trustees, District Staff and Members of the Public, Ms. Mekis was thanked for her excellent presentation. This report was informational in nature, and no actions were taken by the Board of Education regarding this matter.

8.3.1. New Business: Good Tidings Foundation Construction of Sand Volleyball Court for Harbor High School

Superintendent Munro reported that the District is the recipient of a tremendous donation from Olympic Gold Medalist Kerri Walsh Jennings, who, in conjunction with the Good Tidings Foundation, is donating a sand volleyball court to Harbor High School. The agreement that the Board is being asked to approve will enable the Good Tidings Foundation to proceed with the construction of the volleyball court. This contract has been developed by our legal counsel, and reviewed in detail with the Good Tidings Foundation. This agreement is in direct support of the following District goal and its metrics: Goal #5 - SCCS will maintain a balanced budget and efficient and effective management. There is no fiscal impact to the District. MSP (Tracy-Proulx/Threet) 7-0, the Board of Education approved the construction of a sand volleyball court at Harbor High School through the donation of the Good Tidings Foundation and Olympian Kerri Walsh Jennings.

8.3.2. Staff Report: Summer Facility Projects

Mr. Gaffney introduced Facilities Director Miller to report to the Trustees. Mr. Miller reported on summer projects funded through Routine Maintenance, Deferred Maintenance, Redevelopment Agency funding, Proposition 39 Energy funds, and Capital Facility funds (Developer Fees). Projects included: improved playfields; deep cleaned carpets; polished hard floors; refinished middle and high school gym floors. The department also sampled a new type of floor cleaning machine that uses very little water and no chemicals – very green! Following discussion, comments and questions among

Trustees, District Staff and Members of the Public, Mr. Miller was thanked for his presentation. This report was informational in nature, and no actions were taken by the Board of Education regarding this matter.

8.3.4. Staff Report: CAASPP Results

Elementary Curriculum Director Wildman reported to the Trustees on this matter. The California Assessment of Student Performance & Progress (CAASPP) includes: Smarter Balanced Summative Assessments; California Alternative Assessments; CAA for Science pilot; California Science Tests (CASTs) pilot; new assessments for new standards; summative and interim assessments; digital library. In response to the CAASPP data, the district will: increase focus on English Learners; continue to work on Rtl Tier 1 Math; work with the Core Collaborative consultant on learning intentions and success criteria; Coaches and Rtl Coordinators will support teachers with effective educational strategies. Santa Cruz City Schools curriculum and assessment planning includes building an aligned system of assessments to inform instruction. Following discussion, comments and questions among Trustees, District Staff and Members of the Public, Ms. Wildman was thanked for her presentation. This report was informational in nature, and no actions were taken by the Board of Education regarding this matter.

8.3.5. *New Business:* Resolution 9-16-17 Week of the Administrator
